- Pre-Purchase Examination
 - A pre-purchase exam was performed on a 4 year old chesnut gelding, Hes
 Aneat Guy, for a potential buyer, Lilly Bragg, on 1.30.2024
- Soundness Exam
 - The horse was jogged at hand in a medium depth arena and no lameness was observed.
 - o Flexion of all 4 limbs did not cause any change in soundness.
- Physical Exam
 - General / Musculoskeletal
 - The horse has a small sarcoid on he medial aspect of the right front leg, near the inside of the elbow
 - There are also white spots on the right of the neck and the left side of the lower neck. These spots were potentially old sarcoids and are insignificant at this time.
 - All else NSF (No significant findings) / WNL (Within normal limits)
 - o Eyes
 - NSF / WNL
 - o GI
- Normal gut sounds in all four quadrants
- o Heart
 - NSF / WNL
- o Lungs / Airway
 - Normal respiratory noises on both sides of the thorax
- o Reproductive System
 - The external genitalia is NSF / WNL
- o Dental
 - The teeth need routine dental work

- All else NSF / WNL
- o CNS
 - NSF / WNL
- Radiographic Findings
 - Stifles
 - No radiographs obtained
 - o Hocks
